
Teresa Corbin, CEO, Australian Communications Consumer Action Network

Dr Andrew Nance, Director, The Energy Project



Andrew is one of South Australia’s most widely experienced and well respected energy specialists. Starting as a trainee engineer with the Electricity Trust of South Australia at Torrens Island Power Station in 1987, a degree in Electrical Engineering (UniSA Hons) was followed by 10 years of hands-on work with the power systems of the Collins Class Submarine fleet.

Andrew has since served as the Technical Director of the South Australian Government’s Sustainability and Climate Change Division, spent a decade advising the South Australian Council of Social Service (SACOSS), served on the Australian Energy Market Commission’s Reliability Panel and was a member of the Australian Energy Regulator’s Consumer Challenge Panel from 2016-19.

In 2018, Andrew completed a PhD in Energy Policy at University College London and from 2020 will be the Chair of SA Power Networks’ Consumer Consultative Panel and Chair of SA Power Networks’ Connections Working Group.

Robert Morsillo, Digital Inclusion Senior Specialist, Telstra



Robert started talking to Telstra in 1988 as a consumer representative, working in the community sector, and pushing for improvements to the access and affordability of the telephone. In 1995 he was invited to join Telstra to continue some of that work. In 2002 he assisted Telstra in putting together its Access for Everyone programs that seek to assist all Australians to have a basic communications service no matter what their circumstances. In 2011 Telstra formed its Chief Sustainability Office, with a prime focus on digital inclusion, and Robert is now a Senior Specialist in that team. He is a director at Infochange and a member of the governing Council of the University of Divinity. From 2013–20 he was an Adjunct Associate Professor at Swinburne University. Robert has a background and formal qualifications in computer science, theology, community development, public policy and communications. He is particularly interested in the role of technology in encouraging a sense of connectedness, and in encouraging user innovation within the communications industry, on which he has published a number of journal articles.
